8. Electronic bids in the form of Technical and Financial Bid must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 hours on 2082/01/09. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours on 2082/01/09. at the office of **Brindawan Municipality , Office Of the Municipal Executive ,Bishrampur Rautahat ,Madhesh Province**. Bids must be valid for a period of **as mentioned above** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of sum as mentioned above, which shall be valid for 30 days beyond the validity period of the bid
10. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
